

- Out-of-Bounds: Defined by boundary fencing surrounding the golf course and/or white stakes and/or lines. Penalty: stroke and distance. Model Local Rule E-5 is an option for a ball Out of Bounds or deemed to be lost outside of Penalty Area.
- The protective netting and its supports adjacent to Hole 18 and surrounding the Driving Range are Immovable Obstructions. Free relief may be taken under Rule 16.1b.
- Please maintain your position on the golf course to encourage a positive pace of play experience.
- 4. Please repair ball marks, rake bunkers, and fill divots.
- 5. Rakes should be left outside of bunkers parallel to line of play.
